#### To: THE AUTOMOBILE ASSOCIATION OF SOUTH AFRICA

- 1 I hereby apply for the required Carnet(s) de Passages en Douane to enable me to temporarily take the vehicle(s)/boat described on the reverse, to the countries mentioned and I warrant that:
  - (a) the information given on the reverse is true and correct in every respect;
  - (b) I will comply with all customs laws and regulations of the countries visited governing temporary importation of vehicles/boats and in particular all prescriptions relating the use of the Carnet(s) de Passages en Douane;
  - in the two years immediately preceding the date of my intended journey I have not resided, for an aggregate period exceeding 12 months, in any one of the countries I now propose visiting;
  - (d) the vehicle(s)/boat are not the property of any person, firm, company or other concern resident or registered in any of the countries into which it/they will be taken. The vehicle(s)/boat or any part thereof will not be sold, pledged, loaned, hired or placed on at the disposal of such person having a residence or business in any country into which the vehicle(s)/boat will be taken under cover of the Carnet(s) de Passages en Douane, without the prior written consent of the customs authorities concerned and without prior notification to the Automobile Association of South Africa (hereafter called the Association). In the event of such consent being granted, I will follow the instructions of the Association in connection therewith:
  - I will not use the vehicle(s)/boat for hire or commercial purposes and on no account will any fare-paying passenger(s) join and leave the tour in the same country outside South Africa;
  - I will notify the Association as soon as possible of any circumstance preventing or delaying exportation of the vehicle(s)/boat;
  - (g) in the event of irreparable damage to the vehicle(s)/boat or its/their destruction by fire or accident, I will arrange for vehicle(s)/boat or their salvage to be placed in safe custody and I will notify the Association immediately after the occurrence, so that the Association may have the opportunity of safeguarding my interests in respect of the liability incurred by me as a result of the issue of any customs documents. Furthermore, in such event as aforesaid, I will not dispose of, or permit to be disposed of, the vehicle(s)/boat or the salvage until all customs documents have been discharged;
  - (h) I will re-export the vehicle(s)/boat and all parts and accessories from the countries visited within the time limit prescribed by the national customs legislation. In terms of the Carnet(s) de Passages en Douane to be supplied to me, I will ensure that the Carnet(s) de Passages en Douane has/have been discharged by the customs legislation. #### **GENERAL**

#### CARNETS DE PASSAGES EN DOUANE

- May not be issued to persons for the temporary importation of vehicles and boats into countries where they are resident. The vehicles and boats may not be placed at the disposal of any person who is resident in any country into which the vehicles or boats have been temporarily imported without prior written consent of the AASA.
- Are issued subject to the terms and conditions of the declaration set out on this form and remain the property of the AASA.
   Carnets are highly recommended for the temporary exportation of motor vehicles. Their purpose is to guarantee payment of customs duties.

You will not be absolved of your liability arising from the issue of a Carnet nor obtain release of the guarantee, until the issuing motoring organisation is in possession of the properly discharged Carnet, a completed certificate of location (confirming the present whereabouts of the vehicle) or documentation proving that the vehicle has been legally and permanently imported into the country.

#### REFUNDS

Refunds will not normally be made on unused documents. Should a refund be justified due to medical reasons, administrative cost will be deducted.
