

Terms and Conditions for AA Members - F1 Tickets

Competition Rules:

- 1. Each entrant must secure an AA membership to qualify for entry into the competition.
- 2. The winner will be determined by way of a random draw.
- 3. Only valid and paid memberships at the time of the draw qualify. For Family memberships, only the main member will be counted (not the number of additional family members on the subscription).
- 4. All qualifying memberships must comply with the Membership Terms & Conditions handbook, remain valid, and be paid up at the time of the draw.
- 5. Both monthly and annual subscription types qualify.
- 6. Entrants must be 18 years or older and in lawful possession of a valid passport with at least 6 (six) months' validity remaining after the travel dates.

- 1. Return economy-class flights.
